Occupied properties will qualify for Retail relief if they have a rateable value of £50,000 or less, and are wholly or mainly used for one or more of the following purposes:

- Shops (such as: florist, bakers, butchers, grocers, greengrocers, jewellers, stationers, off licence, chemists, newsagents, hardware stores, supermarkets).
- Charity shops
- Opticians
- Post offices
- Furnishing shops/ display rooms (such as: carpet shops, double glazing)
- Car/ caravan show rooms
- Second hard car lots
- Petrol stations
- Garden centres
- Art galleries (where art is for sale/hire)
- Hair and Beauty services (such as hairdressers, nail bars, beauty salons, tanning shops etc)
- Shoe repairs/ key cutting
- Travel agents
- Ticket offices e.g. for theatre
- Dry cleaners
- Launderettes
- PC/ TV/ domestic appliance repair
- Funeral directors
- Photo processing
- DVD/ video rentals

- Restaurants

- Sandwich shops
- Coffee shops
- Pubs
- Bars
