

<b>Heart:</b> No real heart or focal point in the town centre and a lack of places to spend time in (public space etc.)	
Street: The street environment is poor throughout the town centre, there is poor landscaping, planting, paving and bins	
Crime: Perceived high levels of crime in the town centre, particularly at Tally Ho in the evenings	
High Road: Reducing the dominance of the main road, to create a more pleasant pedestrian environment	
<b>Shopping:</b> There are few large shops and lack of quality modern retailers	
Arts Depot: The Arts Depot lacks profile in the local area	
Offices: There is a significant amount of empty office space
